The International Committee of Sports for the Deaf has announced officially that the XX Winter Deaflympics is scheduled to be held at Ankara and Kayseri, Turkiye (Turkey) on March 02 to 12, 2024. The disciplines of (1) Futsal, (2) Chess, (3) Ice Hockey and (4) Curling are at Ankara while (1) Alpine Skiing, (2) Cross Country Skiing and (3) Snowboard at Kayseri.

We wish to write to you that the court case between Adv. Rahul Mehra and MYAS often has been adjourned which led to non-release of financial assistance from MYAS. This further has created agonies among all state units and hence, they are reluctant to organise and host the National Events and there is no way to select to represent this Country in the 20<sup>th</sup> Winter Deaflympics in March 2024. Kindly note that the last date of submission of Final Entry Form is 02<sup>nd</sup> February 2024, and there is no chance for us the National Chess Championship before this deadline date. The Two-day National Chess Selection Trial is likely to be held at the Conference Hall of Mook Badhir Sangthan School & College, Scheme No: 71 B, Behind Ranjeet Hanuman Temple, Indore, Madhya Pradesh on November 25 & 26, 2023. We are going to submit the details to the SAI, HQ, New Delhi for approval. Official announcement will be made only after getting approval from SAI.

Though the respective Affiliated State Unit, only qualified top-level performers are invited to attend the Said trial. No sort of any allowance like Travel Expenses, Food & Accommodation, etc to them will be paid during the Trial. The Entry Fee of Rs. 2,500.00 (Rupees two thousand and five hundred only) per athlete / player shall be paid to AISCD through Affiliated State Units under their jurisdiction and respective state units are responsible for their participation. Mr. Subhash Kapoor, Mr. Kshirsagar Darshan Devikumar and Mr. Bhagya Prakash Sharma shall be members of Selection Sub Committee.

Strictly no parents or personal coach will be allowed inside the Campus during the Selection Trial, failing which strict disciplinary action is liable to be taken against the concerned player.
