The interview was conducted in two phases first phase on 28-03-2026 and the second phase on 30-03-2026.

The selection Committee has decided to select and appoint Mrs. Pinkey Khandewal, daughter of Shri. Rajesh Khandelwal and Smt. Rajni Khandelwal a deaf couple, residing at A-636, Shastri Nagar, Near Rai Dental Clinic, New Delhi – 110052

She has been appointed to hire as Manager Administration in the Delhi Office of the All India Sports Council of the Deaf on the subject to the terms and conditions as given below and the salary of Rs 75,000.00 (Rupees seventy five thousand only) shall be reimbursed from the Sports Authority of India according to the Ministry of Youth Affairs & Sports, Government of India, New Delhi.

Manager Administration's Functions are:

- The Manager Administration will act as a Liaison Officer between the Department and the Federations. Consequently, he/she has to be well conversant with all guidelines and instructions issued from time to time to the Federations.

- The Manager Administration will advise the office-bearers of the Federation about such guidelines and instructions.
- The Manager Administration will be responsible to ensure the all-round efficient functioning of the office of the Federation, including timely submission of proposals for Government clearance/financial assistance and the like.
- The Manager Administration will help in preparing the annual accounts of the Federation and submitting the same to the Government well in time. In case there is likelihood of any delay in submitting such accounts by the Federation, the Manager Administration shall inform the Government of the same with reasons therefor.
- Prior approval of the Government in the Department of Youth Affairs & Sports shall be taken in respect of termination of the services of the Manager Administration, approved under the Scheme of Assistance, if it is proposed to so terminate his/her services before the expiry of the period for which such assistance has been sanctioned by Government.
- Leave from office shall be similar as per the Central Government Servant Rules but in the Federation Rules.
- Ten percent of the amount of the donation & sponsorship will be given to the Assistant Secretary if he/she has influence.
- An increment of 7% as per government norms shall be given every year.

Mrs. Pinkey Khandelwal is requested to join duty as Manager Administration on the forenoon Wednesday 01st of April 2026 (01-04-2026) at 1-B, Institutional Area, Near Janta Flats, Sarita Vihar, New Delhi – 110 076 positively if the terms and conditions mentioned above are accepted.
